The meeting was opened at 0705 by Matt Morris, President. The Group stood and recited the Pledge of Allegiance. (Henry Shinn KC3KGY donated the new flag, pole and stand. Many thanks to Henry for his donation.)

David welcomed the other 8 in attendance. There were 2 participants via the ZOOM presentation tonight: Jeff White KE8RAW and Charlie Hampton N8CEH.

Hooger read the minutes of the March 4, 2024 meeting and they were accepted.

Treasurer's report: Deposits included \$36.00 from a 50/50 drawing and a \$84.00 payment for our PO Box rental.. Our PayPal had a \$16.00 deposit and a \$1.05 fee payment. The PayPal link is on our www.HamclubOnline.com link.

Skywarn: Matt said that there's been around 30 checkins on the net the last month. Chris Hatcher WV8CH would like to get the Southern WV/Charleston ARES net going again. It was asked if we could join this net with the equipment that we have. Nelson Linkous WZ8E said that we'd need to replace the controller on 145.49 as it is incompatible and/or add a remote base. Discussion. Nelson said that the Club can use the 147.06 repeater on Windmill Gap as a System Fusion digital repeater and move the analog 147.06 repeater to Melody Mountain in Princeton (WAEY / Star 95 site). We would need a set of duplexers for the digital site. It has been Okd by the SERA (www.sera.org) coordination organization. Jay Belt and Nelson will get together and see what needs to be done and report back to the membership. Gary Kadar N8GK asked if the separation of receive and transmit antennas for the 145.49 can be tried in order to get the noise out of the repeater. It can be done but we would need an extra antenna. Discussion. Nelson and Jay will look into this also. Nelson mentioned that the ARA is totally revamping the 146.955 repeater in Springville, Va with new everything. It will be 'booming' again and cover Bristol to Roanoke and cover Tazewell, Va and other under-served areas.

ARES: Matt has had 7-9 checkins on the monthly net and would like to see more. He's on the Mercer County, WV Local Emergency Planning Committee (LEPC) and has been in contact with Keith Gunnoe, the Mercer Emergency Coordinator. Keith would like us to go thru the multiple scenarios

on the Emergency Plan and comment as to how ARES could help. Matt mentioned that one of the Kenwood 2000 needs to be returned to the 911 Center as per original agreements.

We began to go over the "To Do" list. "To Do list":

1) Echolink is now located at Jay Belt's Bland Street shop. The Kenwood 2M radio needs a component before it can be back on the air,

2) Additional 2M, 440, radios into our Radio Room. There was lots of discussion on this subject. We have three HF rigs at the 911 Center in storage. There is a free-standing 440 radio at the 911 Center. Nelson suggested that we get two Yaesu FT300B (https://www.gigaparts.com/yaesu-ftm-300dr-c4fm-dual-band-transceiver.html) that are dual band, have a full warranty and supports System Fusion digital voice. Discussion. John Riddle N8RIG made a motion, seconded by David Lester to purchase said radios, dual band antennas and feedlines, approximately a \$1000 purchase, for use in our radio room. A vote was taken, the motion passed. After this purchase, we can have stand-alone 2M, 440, HF voice and HF digital communications when in a true emergency.

## 3) Special Event Station at Princeton Railroad Museum

Matt and Jeff White KB8RAW have been in contact with them and hope that the Club can give a demonstration on Morse Code and hold a Special Event Station on air at the event. Jeff suggested that we try to use a special callsign NW8VGN (Norfolk Western VirGiNian Railway). Nelson said that he has a contact that can make great QSL cards and Jeff has the perfect picture for the card. Gary Kadar suggested that (we) contact Mike Walters W8ZY and seek advice and help with the particulars. Randall Hash WB4BBF is excited to be the CW performer at the event. He hopes to dress the part of and old time telegrapher.
