DMR: David Sexton AB8D: Net is every Tuesday at 0730pm on the WZ8E 443.625 DMR repeater on the 1354 WV statewide talk group. He usually has a dozen or so check ins and would like to advertise the net on Facebook.

ARES report from Keith Jennings AD8L and Greg Dominguez AF8GD: Charles Priest KN4OOH, Mercer County, WV EC is actively moving back to Tennessee and will be done teaching by the end of this semester. Please keep Charles' mother in your prayers as she is ill. Greg had 5 check ins on the 21st and said that the next monthly net will be on February 18. The net is on the third Thursday at 0730pm on 147.06. Keith and Matt expressed the need for a new ARRL Emergency Coordinator for Mercer County. New business: Keith mentioned that on December 7, 2020, there were two men on the 147.06 that were very very vulgar in their speech. Several amateurs heard it, but Keith did not. Comments were left on Facebook. Keith asked the membership to think about allowing some members to know the 'knock down' codes to the repeaters if situations like this were to happen again. Greg asked that we consider using the W8MOP call sign when challenging someone like this on the air. He suggests that an offender could find out the physical address by way of an internet search of one's call sign and that may not turn out to good. Gary Kadar N8GK suggested that sometimes the best response to offenders is no response at all. If they see that they're not getting a response, hopefully they will go away. He also mentioned that one can listen to the input frequency to see how close the offender may be to the Ham's receiver. Gary also reminded us that if you mistakenly sit on an open mic that the 'offender' is not going to hear you report it to you since your mic is open.
